FY2003 Annual Report



2002-2003 Achievements

The Association achieved significant progress towards its sanctuary protection mission in fiscal year 2003 (FY2003). These achievements were made possible through the support of members, donors, and volunteers, and the partnership with other non-profit groups and agencies. In FY2003, the Association hired a new executive director, moved core programs forward towards protection and education goals, determined its long-range strategic plan, and partnered with the sanctuary to determine its long range direction through the joint management plan review. As FY2004 dawned, the Association renewed its commitment to protecting the rich habitat and wildlife of the sanctuary by nurturing the development of a diverse community of informed and active sanctuary stewards. This year will be a year of new program development, identity evolution, and continued emphasis on growing our core programs.

Volunteer Stewardship

Beach Watch

- Provided analyses for the Natural Resources Damage Assessment for the *S/S Jacob Luckenbach* oil spill, with estimated damage to seabirds in the thousands.
- Coordinated the monitoring of 75 volunteers on 55 beaches throughout Marin, San Francisco, and San Mateo counties.

Sanctuary Education, Awareness, & Long-term Stewardship (SEALS)

- Through their presence on Tomales Bay mudflats, volunteers reduced the pedestrian-associated disturbances to harbor seals from 43% to 2%.
- Continued to gather disturbance information that will form the basis of evolved program development.
- During the spring, trained 37 new volunteers.
- Coordinated the work of 80 volunteers who contributed 830 hours at Tomales Bay and 560 hours at Bolinas Lagoon towards monitoring harbor seals and educating visitors.

Education

Coastal Ecosystem Education Program

- Trained and supported 300 high school students from 11 schools in San Francisco, Marin, Lower Lake, and San Mateo counties in monitoring for sand crabs; they contributed over 1500 hours of service.
- Held the second annual Coastal Ecosystem teacher workshop in July and first LiMPETS (Long-term Monitoring Program & Experiential Training for Students) workshop in March, enabling 25 teachers to learn how to engage their students in monitoring projects.

Interpretation & Outreach

OceanFest 2002

- Attracted 4,000 attendees from the greater Bay Area and beyond to these festivities at Crissy Field to help celebrate the sanctuary on October 12, 2002.

- Raised more than \$15,000 net through donations to the silent auction, wine and beer tasting, and the sustainable seafood and vegetarian grill.

Sanctuary Explorer Camp

- For the second year, exposed 100 under served youth from the San Francisco Department of Parks & Recreation programs from Tenderlion, Garfield Park, Douglass, Presidio Heights, Richmond, Joseph Lee, and Moscone Recreational Centers, to the sanctuary and the marine environment, many for the first time.
- Notable feedback from participants included: "The best part was that we got to know places and things that we didn't know!"

Sanctuary Visitor Center, Lecture Series & Adventure Trips

- Reached over 28,675 visitors at the Crissy Field and Pacifica visitor centers.
- Exposed 900 children ages 4 to 12 to marine concepts through visitor center programming.
- Reached over 400 attendees through the lecture series. Topics included El niño effects, white shark research, Cordell Bank exploration, coastal upwelling, and shipwrecks off the San Francisco coast.
- Informed over 200 participants about the sanctuary through kayaking, tide pooling, bird watching, and whale watching excursions.

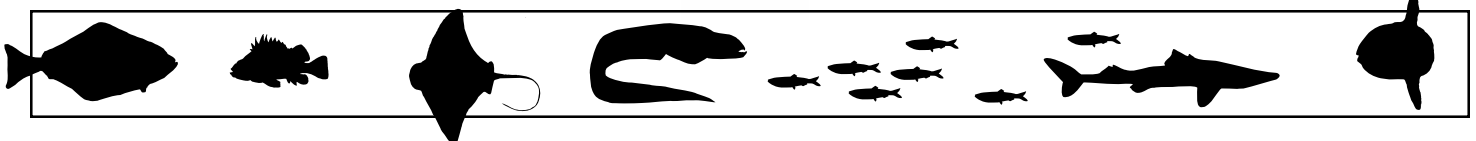
Management/ Administration

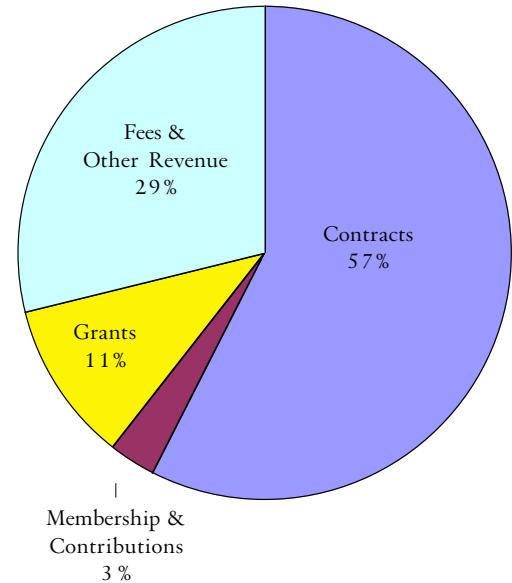

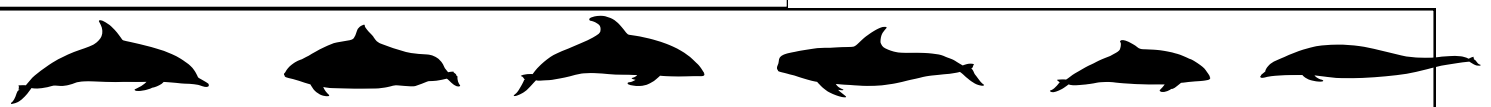
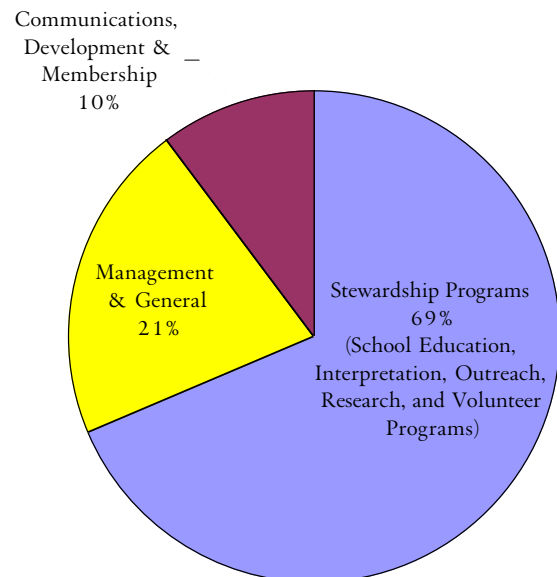
NET ASSETS AT BEGINNING OF YEAR 242,624
